In the reference 1st read above, Extension of temporary Recognition to classes VI to X (E.M) has been granted for only one year i.e., 2019-2020, due to the non submission of the NOCS i.e., fire Certificate and Structural soundness Certificate in respect of Pragati High School, D.No.6-1-18 Main Road Sattenapalli, Guntur District. In the reference 2nd read above, the correspondent of the School duly submitting the above said documents, requested to issue orders of Extension Temporary Recognition to Pragati High School, D.No.6-1-18 Main Road Sattenapalli, Guntur District for further period. On Perusing of the entire documents of the school and keeping in view of the previous recommendations of the District Educational Officer, Guntur and Deputy Educational Officer, Sattenapalli, Guntur District and as per the conditions laid down in GO.Ms.No:1 Edn., (PS-I) Rules Department Dt:1-1-1994, the school is eligible for grant of Extension of Temporary Recognition from 2019-2020 to 2027-2028.

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No: 1 Edn, Date:1-1-1994 ,G.O.Ms.No.41 Edn, Date: 11-05-2006, G.O.Ms.No. 74 Education Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 10th cited, the Regional Joint Director of School Education, Guntur is hereby accords for grant of Extension of temporary Recognition to classes VI to X (EM) for a period of 09(nine) years from the academic year 2019-2020 to 2027-2028 in respect of Pragati High School, D.No.6-1-18 Main Road, Sattenapalli Guntur District without aid now or in future. However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

- 1.That the society shall abided the Instructions, rules and regulations made by Government or authorized officer from time to time.
- 2. That the Educational Institution shall serve the needs of the locality more Particularly.
- 3. That the Instructions shall adopt the curriculum and syllabus prescribed from time to time.
- 4.The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
- 5. That the qualified staff with in the age limits prescribed by Govt, for Govt., Employees shall be appointed as per the Staff pattern.
- 6. That the results of the Institutions shall be satisfactory every year.
- 7. That the records /accounts shall be furnished to the D.E.O every year.
- 8. That the list of Governing body shall be furnished to the D.E.O. every year.
- 9.That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
- 10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
- 11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
- 12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
- 13. That the society shall submit proposal for renewal of Extension of Temporary Recognition sufficiently in advance i.e., at least 6 months prior to the date of Expiry of the renewal.
- 14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
- 15. The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Sattenapalli and District Educational Officer, Guntur District.
- 16. The Management is requested to renewal the Vehicle Fitness Certificate every year from the concerned authorities without fail and submits the same to the concerned Deputy Educational Officer.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for extension of Temporary Recognition for the year 2028-3031
